
RESOLUTION NO. 538

RESOLUTION RESPECTFULLY ENJOINING ALL 61 PUNONG BARANGAYS OF BACOLOD CITY TO ACTIVELY PARTICIPATE AND CELEBRATE THE WHOLE MONTH OF JULY AS NUTRITION MONTH AND ENCOURAGE THEIR CONSTITUENTS TO PRACTICE A HEALTHY LIFESTYLE.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Cindy T. Rojas and Lady Gles Gonzales-Pallen, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Presidential Decree 491 of 1974 or the Nutrition Act of the Philippines created the National Nutrition Council (NNC) to supervise, coordinate and evaluate the implementation of the National Nutrition Program which shall be implemented by all agencies and instrumentalities of both the government and the private sector concerned with improving the nutrition of our people. The NNC shall coordinate and integrate policies and programs of all agencies and instrumentalities of the government charged with the prosecution of existing law, policies, rules and regulations concerning nutrition;



WHEREAS, the Local Government Code of 1991 (Republic Act 7160) mandates local government units to exercise their powers and discharge their functions as are necessary and appropriate for the effective provision of basic services including child welfare and nutrition services;

WHEREAS, the month of July is designated as Nutrition Month, which promotes and encourages the general public of the importance of a balanced and affordable diet and healthy lifestyle, with the theme, "Sama-sama sa Nutrisyong Sapat, Para Sa Lahat";

WHEREAS, all 61 Punong Barangays of Bacolod City are respectfully enjoined to celebrate, promote and provide awareness to the general public of the importance of balanced diet, healthy lifestyle, and health consciousness;

WHEREAS, the public is enjoined to support the Nutrition Month activities and our partner stakeholders to continuously engage and enhance their respective current plans of action for nutrition;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully enjoin all 61 Punong Barangays of Bacolod City to actively participate and celebrate the whole month of July as Nutrition Month and encourage their constituents to practice a healthy lifestyle.


