Dear Mr. Angeles,

We are pleased to inform you that, based on the recommendation of the Public-Private Partnership Pre-Qualification Bids and Awards Committee Report dated January 13, 2025 the Public-Private Partnership Project under a Build-Transfer-Maintain Agreement to coordinate, collaborate and cooperate in connection with the establishment of a Centralized Command Center, Intelligent Street Lamp Poles with Video Surveillance Analytics, Property and Tax Assessment System, and Geographical Information System aimed towards making Bacolod City a Super City (the "**Project**"), with a project cost of Two Billion One Hundred Five Million Two Hundred Eighty-Five Thousand Two Hundred Seventy-Three Pesos (Php 2,105,285,273.00), is hereby awarded to the Original Proponent, **HIGHDATA INFRA CORP** (the "Winning Private Proponent").

*Pursuant to Section 101 of Republic Act No. 11966 or the "Public-Private Partnership (PPP) Code of the Philippines" and its Implementing Rules and Regulations (IRR), and pursuant to the Instructions to Challengers issued for this Project, we are issuing this Notice of Award to the winning Private Proponent.*

*Accordingly, you are hereby **required to conform** to this NOA by affixing your name and signature on the space provided below and return the same to the PBAC **within twenty (20) calendar days** from its official receipt with the following documents ("**Post-Award Requirements**"):*

1. Prescribed performance security under the Build-Transfer-Maintain Agreement of the Project;
2. Proof of commitment of the required equity contribution in the form of a Treasurer's Affidavit or Certification attesting to actual paid-up capital, subscription, agreement between shareholders of the of the winning Proponent and the winning Proponent itself covering said equity contribution, or shareholders agreement between and amongst two(92) or more shareholders of the winning Proponent undertaking to contribute or subscribe the required equity contribution;
3. Proof of commitments from reputable financial institution to provide sufficient credit lines to cover the Project Cost to be shouldered by the winning Private Proponent.
4. Authority of the authorized signatory of the Winning Private Proponent to sign the agreement; and

Please be reminded that failure to submit the above-stated requirements within the prescribed period shall result in the automatic cancellation of this Notice of Award and the confiscation of the Winning Private Proponent's bid security.

Within five (5) calendar days from receipt of the Post-Award Requirements, the City of Bacolod shall determine its compliance with all the requirements stated in this NOA and notify the Winning Private Proponent thereafter.

The Winning Private Proponent is also required, within five (5) calendar days, to sign the Contract from the receipt of notice from the City of Bacolod that all conditions stated in the Notice of Award have been complied with. Failure to enter into the Contract by the Winning Private Proponent within the prescribed period shall be ground for the forfeiture of the Winning Private Proponent's bid security and the withdrawal of this Notice of Award.
