RESOLUTION RATIFYING THE BUILD-TRANSFER-MAINTAIN AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF BACOLOD, REPRESENTED BY THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ, AND HIGHDATA INFRA CORP., RE: ESTABLISHMENT OF A CENTRALIZED COMMAND CENTER, INTELLIGENT STREET LAMP POLES WITH VIDEO SURVEILLANCE ANALYTICS, PROPERTY AND TAX ASSESSMENT SYSTEM AND GEOGRAPHICAL INFORMATION SYSTEM AIMED TOWARDS MAKING BACOLOD CITY A SUPER CITY IN THE AMOUNT OF TWO BILLION ONE HUNDRED FIVE MILLION TWO HUNDRED EIGHTY-FIVE THOUSAND TWO HUNDRED SEVENTY-THREE PESOS (PHP2,105,285,273.00), DULY NOTARIZED AND DOCKETED AS SP CORRESPONDENCE NO. 11-25-0111-E.




